**GENERAL ORDERS
NUMBER DPL 06 - 11**

RESTRUCTURING OF UNIT

1. Effective this date, the Regional Intelligence and Investigation Division under the Police Regional Office will be separated into two (2) Divisions, namely: the Regional Intelligence Division (RID); and the Regional Investigation and Detective Management Division (RIDMD).


2. The Regional Intelligence Division shall be headed by a PCO with the rank of Police Senior Superintendent and shall be composed of three (3) Sections, namely: 1) Intelligence Operations, Liaison and Training Section; 2) Counter-Intelligence and Security Section; and 3) Intelligence Research Section.

3. The Regional Investigation and Detective Management Division (RIDMD) will be headed by a PCO with the rank of Police Senior Superintendent and shall be composed of four (4) Sections, namely: 1) Investigation Section; 2) Detective Management Section; 3) Criminal Records Management and Evidence Section; and 4) Pre-Charge Investigation Section.

4. Initial personnel, equipment, facilities and funding requirements shall be provided by the respective Regional Directors of the Police Regional Offices. Additional requirements shall be submitted to NHQ, PNP attention concerned Directorial Staff for appropriate action.

5. The issuance of this General Orders is in pursuance to the vested powers of the Chief, PNP under Section 26 of Republic Act No. 6975.

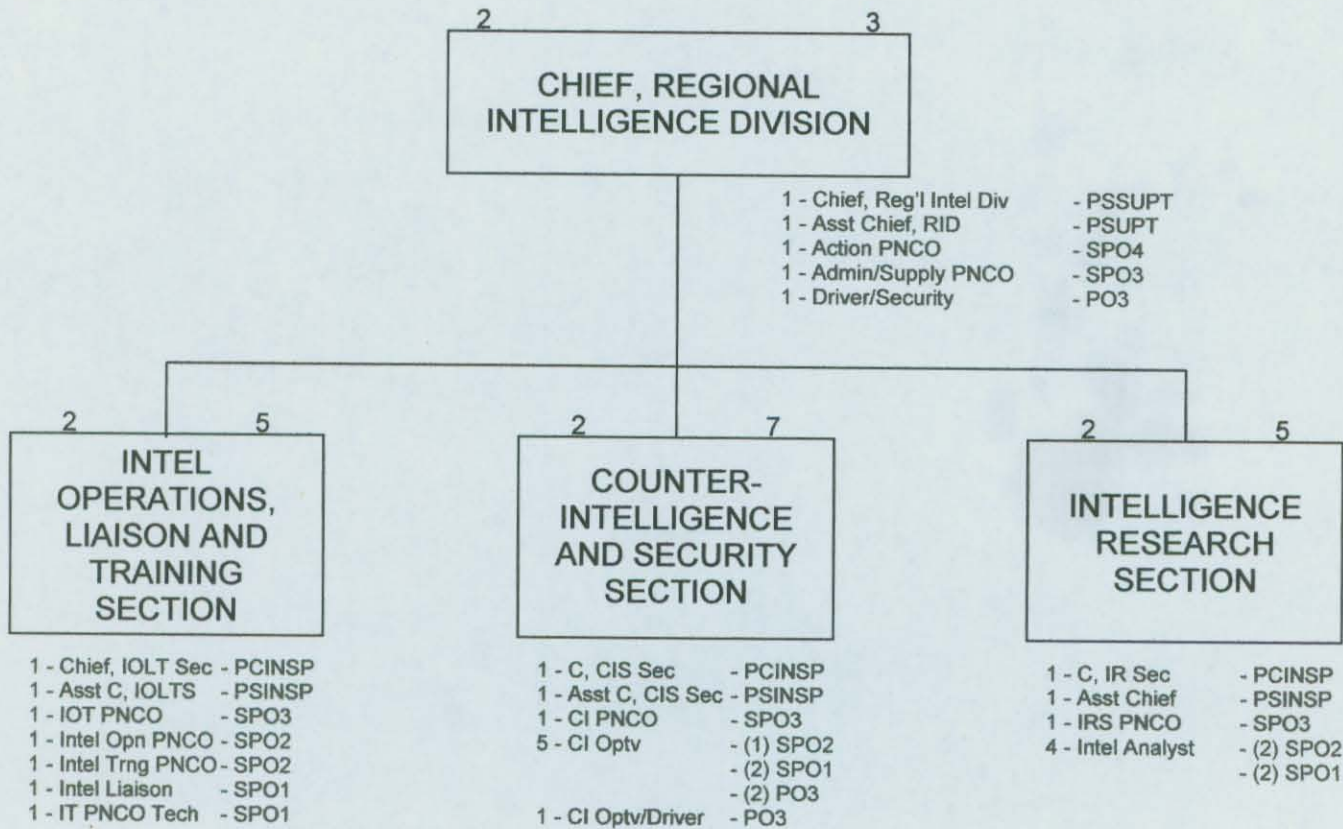

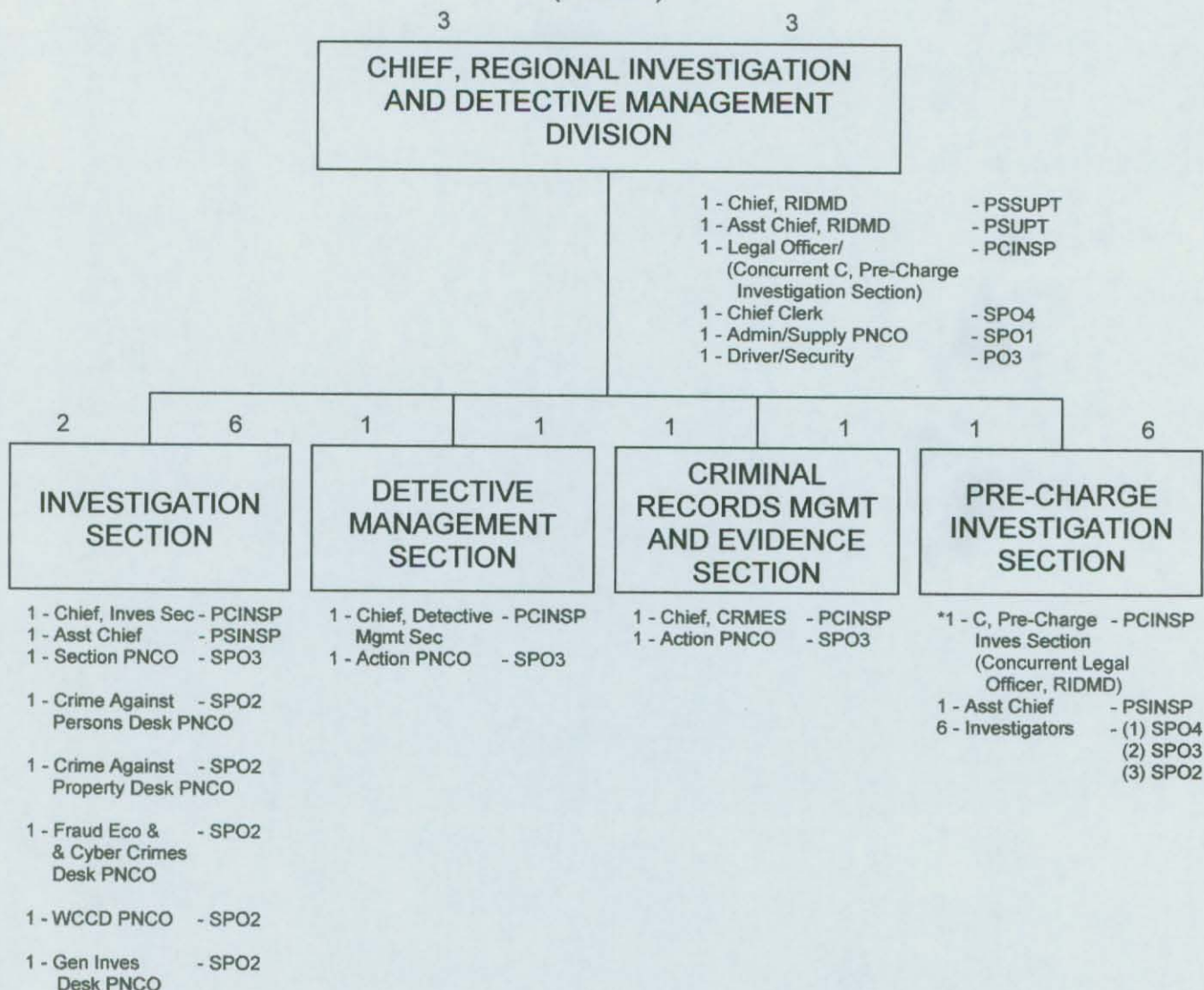
PROPOSED STAFFING PATTERN AND ORGANIZATIONAL STRUCTURE

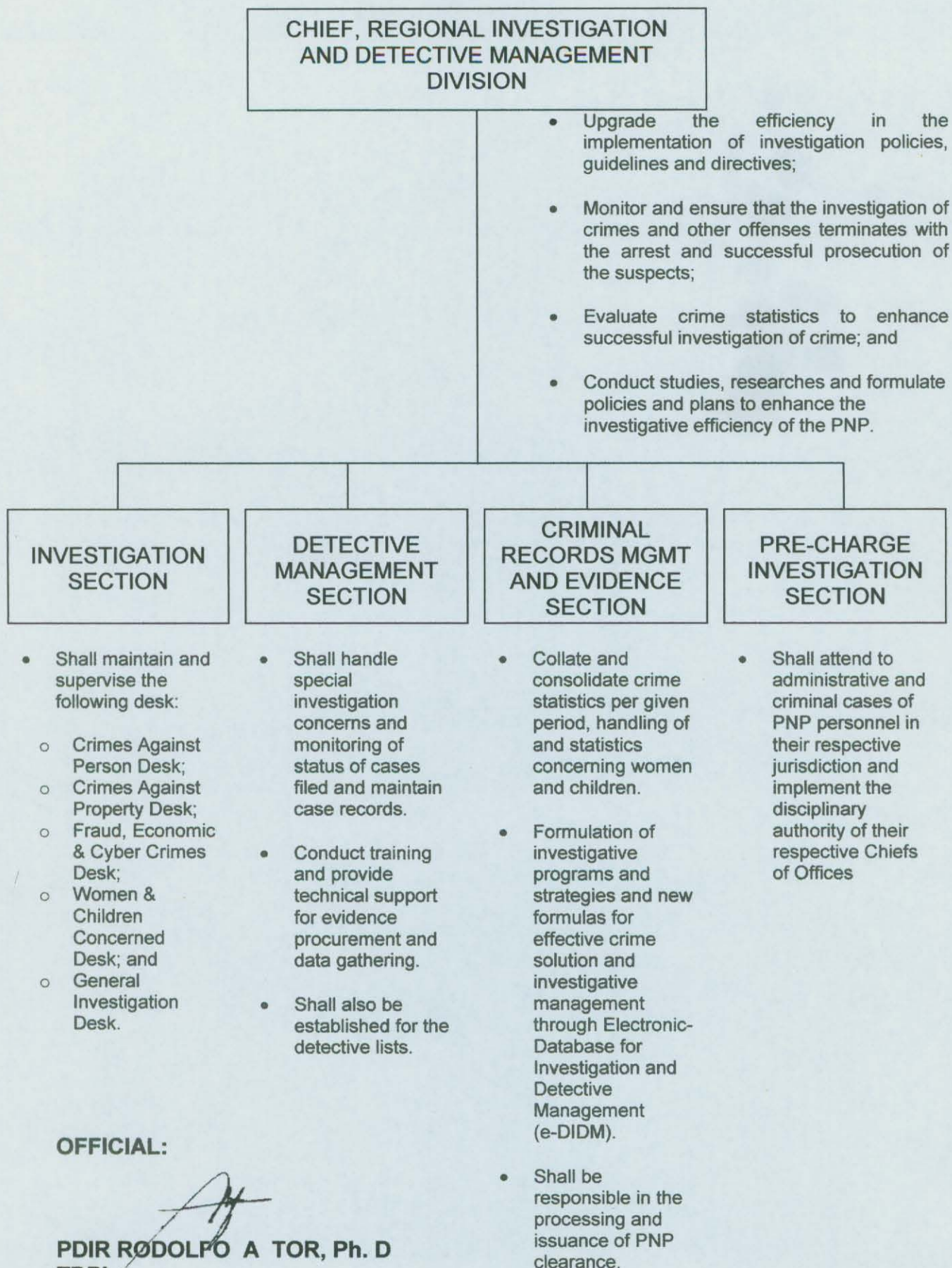

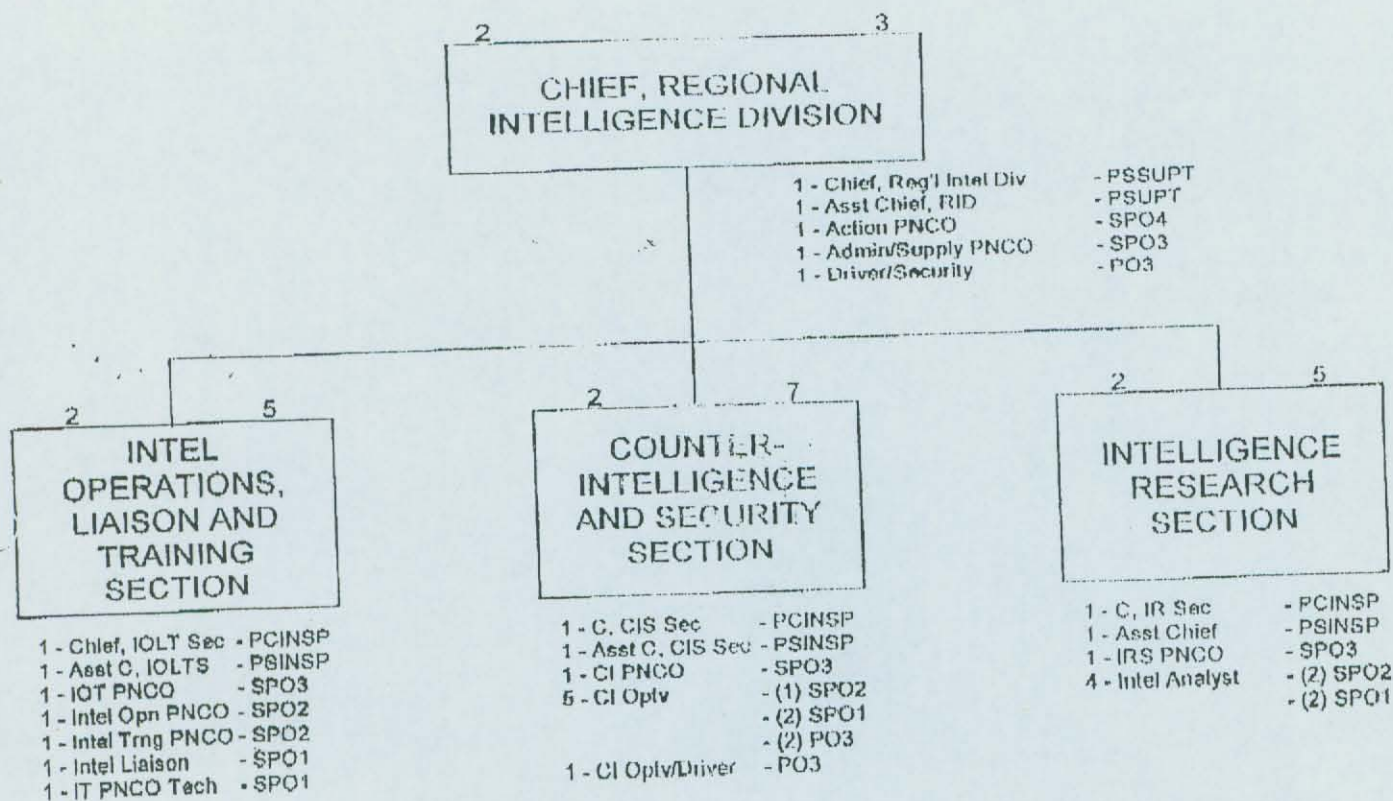

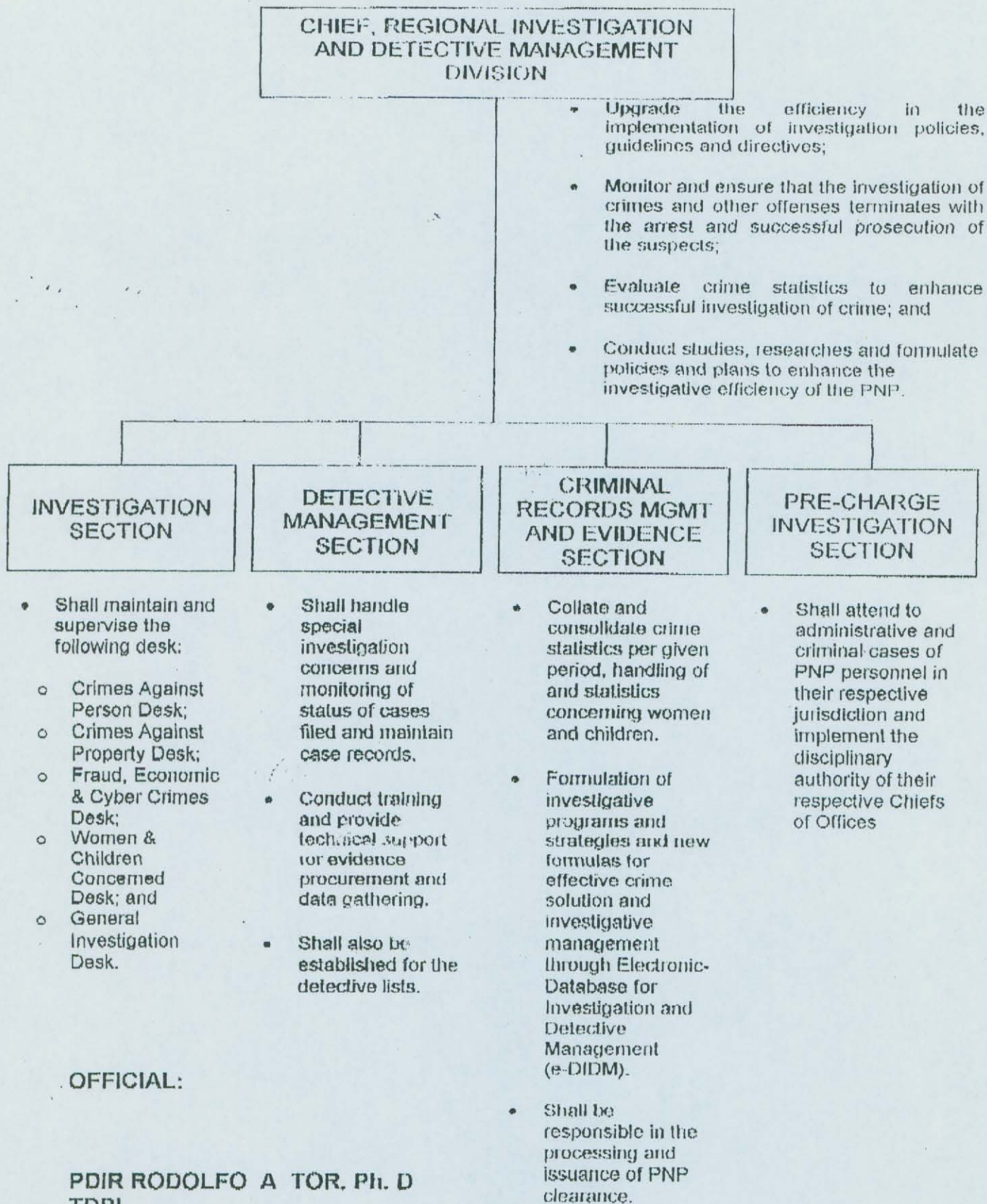

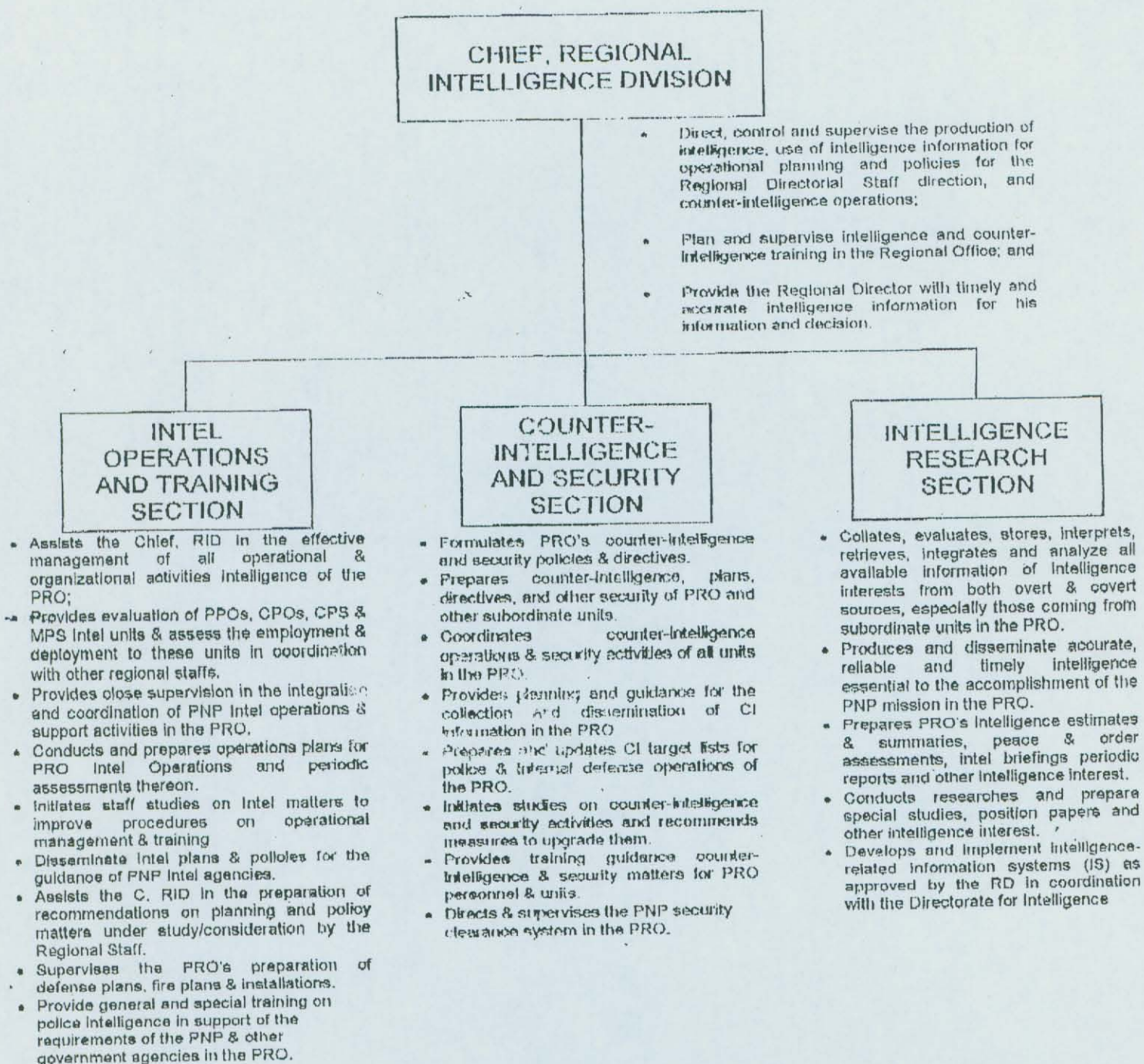

Dear Chairman Puno:

The PNP intends to separate the Regional Intelligence and Investigation Division (RIID) to make it more effective and efficient in its field of specialization.

Part of this proposed separation is the renaming of the Regional Intelligence and Investigation Division (RIID) into Regional Intelligence Division and Regional Investigation and Detective Management Division, Restructuring of Unit including the Staffing Pattern for Uniformed Personnel and Functional Chart.

The separation prescribes to support the following:

- a. Reshape the way in which the affected police officers will perform their task;
- b. Promote career growth and development among eligible officers;
- c. Have their own mandated task distinctive of each other;
- d. An aggressive role in Internal Security Operations (ISO);
- e. Check-in-balance between the two (2) Divisions;


g. Ensure that professional standards are maintained in each area of expertise; and

h. Coordination between NHQ (DI and DIDM) with counterpart at the RHQ will be effective and efficient because of clear demarcation of functions.

In this regard, attached for consideration of the commission is NHQ-PNP General Orders Number DPL 06-11 providing for the separation of the Regional Intelligence and Investigation Division (RIID) into Regional Intelligence Division (RID) and Regional Investigation and Detective Management Division (RIDMD).

RESOLUTION NO. 2006 - 486

**APPROVING THE SEPARATION OF THE REGIONAL INTELLIGENCE AND INVESTIGATION
DIVISION (RIID) AS PROVIDED FOR UNDER PNP GENERAL ORDERS NUMBER DPL 06-11**

WHEREAS, Section 14 (a) of Republic Act No. 6975, as amended, provides that the Commission shall exercise administrative control and operational supervision over the Philippine National Police;


WHEREAS, the Chief, PNP submitted for consideration of the Commission General Orders Number DPL 06-11 providing for the separation of the Regional Intelligence and Investigation Division (RIID) into Regional Intelligence Division (RID) and Regional Investigation and Detective Management Division (RIDMD);

WHEREAS, the Commission acknowledged that the proposed separation of the said Division is intended to strengthen the intelligence organization and function of the PNP, especially with the active participation of the citizenry through the Peace and Order Councils (POCs), in gathering vital information in support of Internal Security Operations (ISO);


WHEREAS, after evaluation of the proposal, the Commission finds the same to be in order after taking into consideration Executive Order No. 546 S. 2006 which directed the PNP to undertake active support to the Armed Forces of the Philippines (AFP) in ISO for the suppression of insurgency and other serious threats to national security;

NOW, THEREFORE, the Commission in the exercise of its statutory powers and functions to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the separation of the Regional Intelligence and Investigation Division (RIID) as provided for under PNP General Orders Number DPL 06-11 attached hereof as Annex "A".





