

2. This pertains to the Facial Composite Illustrations of suspects on all TF USIG cases which was submitted to this Directorate. It has been observed that information placed on Facial Composite Illustrations lacks the necessary data for critical evaluation which could provide leads to the possible identification of the suspects.

3. In relation to the foregoing, all Facial Composite Illustrations which shall be undertaken in the future should not only contain the basic description of suspects but also ample information which is necessary in cross referencing with other suspects engaged in crimes of similar nature and employment of similar Modus Operandi.

4. Attached is the existing format used by the PNP Crime Laboratory which shall be the standard format for all future facial composite of suspects that could be generated through the computerized system or illustration of an artist.
